Sub: To participate of the delegate of Ministry of Expatriates' Welfare & Overseas Employment on the topic of the Swedish legal migration framework and asylum process.



02. The terms and conditions of this order are mentioned below:

- (i) The Period of visit including transit and travel time will be treated as on duty.
- (ii) He will draw his usual pay and allowances from Bangladesh in local currency.
- (iii) The expenses regarding travel, accommodation & meal of A F M Hayatullah, Deputy Secretary (PS to Minister), Ministry of Public Administration will be borne by International Center for Migration Policy Development (ICMDP). In addition to that 30% Pocket Money according to foreign tour rules endorsed by Finance Division, Ministry of Finance(memo no.221 dated .09-10-12) Article-11 and 25% transit allowance according to Article 13(B) & 13(D) of the said rule will be borne by the Ministry of Public Administration.
- (iv) On return from abroad he will submit a report on the said training programme within 15 days.
