(2) Accommodation and travel cost of Mr. Md. Nurul Islam, Director in this connection will be borne by International Organisation for Migration (IOM). In addition to that 30% Pocket Money according to foreign tour rules Article-11 and 25% transit allowance according to Article 13(B) & 13(D) will be borne by related fund of BMET.
- (e) On return from abroad they will report to their place of posting and submit a report on the said programme within 15 days.
